The Commission launched National Electoral Roll Purification & Authentication Programme (NERPAP), 2015 on 3rd March 2015 in all States/Union Territories with major objective of linking of Aadhaar with Electoral Roll database. In August, 2015 when collection, feeding and seeding of Aadhaar number were in full swing, the Commission suspended all activities relating to collection/feeding/seeding of Aadhaar number, being undertaken under NERPAP in light of Hon'ble Supreme Court's interim order dated 11.08.2015 in WP(C) No. 494 of 2012 vide it's letter dated 13.08.2015.
